### CRITERIA:

1. A nomination form will be sent to all members of the relevant Reunion classes.
2. Submission of nominations must include support for the award criteria (e.g., a written paragraph, bio, etc.). Nominees may be notified in order to gain the support needed.
3. Nominations must be submitted to the Alumnae Relations Office by the stated deadline date.
4. A selection committee composed of members of the Alumnae Board and other alumnae volunteers will review all nominations and select a primary and secondary candidate for each award.
5. Primary and secondary candidates for each award will be submitted to the president of Trinity High School for final approval.

### NOTIFYING THE CANDIDATE

Upon receiving final approval from Trinity's president, the Alumnae Association president will contact the candidate by phone and inform her of her *nomination*. The candidate will be told that she has been nominated to receive the award and one of the criteria to receive it is her presence at the liturgy on Sat., Oct. 15, 2011.
